







# LED is recommended for reflow soldering and soldering profile is shown below.

## Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. Maximum soldering temperature should not exceed 260°C
- 2. Recommended reflow temperature: 145°C-260°C
- 3. Do not put stress to the epoxy resin during high temperatures conditions








# **❖** Recommended Soldering Pattern (Units: mm; Tolerance: $\pm 0.1$ )


- 1. Wavelength: +/-1nm

- 3. Forward Voltage: +/-0.1V




